In particular, the use of Public Private Partnerships (PPPs) as means to develop its infrastructure and delivery of services.

In line with above objective, Ashghal has identified an opportunity for a private investor to Build, Lease, Operate and Transfer ("BLOT") office administration buildings within Hamad Bin Khalifa Medical City, as illustrated below.
