Accordingly, we assume that experience of healthcare projects is also valid for 3th topic of the mentioned table. Clarification is needed.	Confirmed.
2.	8th topic of the table shared under Article 8.1, regional experience defined as “construction or facilities management experience for at least one similar project within the GCC.” We assume that “similar projects” includes education, healthcare and real estate projects. Clarification is needed.	Confirmed.
3.	8 th topic of the table shared under Article 8.1, it is mentioned that the Respondent should have “Regional Experience”. We assume that the experience in Turkey, which is a Middle East country is also valid for the “Regional Experience”. Clarification is needed.	Confirmed.
4.	Article 8.2 includes the SOQ Evaluation Criteria in Technical Section. We assume that “similar facilities” mentioned in this article also consist of healthcare and real estate projects. Clarification is needed.	Confirmed.

6.	Article 6.1 mentions that Consortium must have the experience of education or real estate sector. Having been mentioned in Article 8, we assume that the experience of healthcare projects are also valid for this article. Clarification is needed.	Confirmed.
7.	Article 6.1 mentions that the leader of the Consortium must have the experience of similar projects. Having been mentioned in Article 8, we assume that the experience of education or real estate or healthcare projects are also valid for this article. Clarification is needed.	Confirmed.
8.	Article 3.3 mentions that the leader of the Consortium must have the experience of education projects. Having been mentioned in Article 8, we assume that the experience of education or real estate or healthcare projects are also valid for this article. Clarification is needed.	Confirmed.
9.	Article 2.2 mentions that the Respondents must have the experience of education/real estate projects. Having been mentioned in Article 8, we assume that the experience of healthcare projects are also valid for this article. Clarification is needed.	Confirmed.
10.	Article 6.3 mentions that the SOQ Package shall contain 4 hard copies and 4 soft copies. We assume that 1 of 4 hard copies is original and 3 of 4 hard copies are the photocopy of the original package. Clarification is needed.	Confirmed.
