- 5. IT IS RECOMMENDED TO HAVE ON-CARRIAGEWAY PARKING RESTRICTIONS FOR A LENGTH OF ATLEAST 20M BEFORE AND 10M AFTER PEDESTRIAN CROSSINGS BOLLARDS SHALL BE USED ON THE FOOTPATHS TO ENFORCE THIS RESTRICTION IN ADDITION TO SIGNS AND MARKINGS.
- KERB BUILD OUTS SHALL BE USED WITH PEDESTRIAN CROSSING TO REDUCE THE WIDTH OF CARRIAGEWAY THAT PEDESTRIAN CROSSING AS WELL AS TO RESTRICT PARKING TOO CLOSE TO THE PEDESTRIAN CROSSING.
