The Public Works Authority in the State of Qatar seek to prequalify competent and eligible Contractors with relevant capabilities and experiences for the procurement of Design and Build (D&B) contracting services for the proposed RECLAMATION AND REHABILITATION OF AL KARAANA LAGOON (RRKL) in Qatar. The prospective Contractors/Joint Ventures (JV) who express interest participating in the bidding process are hereby invited to submit their prequalification documents in accordance with the requirements prescribed below. Tenders for the contracting services will be based on a closed tendering process, and will be invited only from the select list of successfully prequalified Contractors/Joint Ventures (JV).

#### BRIEF DESCRIPTION OF THE WORKS

Al Karaana Lagoon is a major 4 km<sup>2</sup> sewage disposal site, which is located approximately 55 km from central Doha along Salwa Road towards the southern borders. The lagoons have been in use since 2007 and comprise 6 unlined lagoons into which raw sewage is disposed. Al Karaana Lagoons have been accepting an average of approximately 60,000 m3/d of untreated sewage. Currently, Al Karaana Lagoons receive approximately 4,000 m3/d of untreated industrial sewage discharged by light to medium industrial installations.

In response to the Public Works Authority decision to close Al Karaana Lagoon, the RECLAMATION AND REHABILITATION OF AL KARAANA LAGOON (RRKL) project is launched which comprises of removal and disposal of the stored liquid and solid sediments, restore and rehabilitate the site with a landscaping project in order to blend it with the surrounding nature.

The reclamation and rehabilitation works are required to be completed by end of 2016.
