### **INVITATION TO PRE-QUALIFY**

Ashghal - Public Works Authority (PWA) – Building Affairs, Qatar, wishes to pre-qualify competent companies (the "Pre-qualified Applicants"), for selection to a vendor list for 'Modular Wall Systems for Healthcare Projects'. The PWA are undertaking an extensive programme of healthcare projects across the State of Qatar.

The PWA is seeking pre-qualifications from applicants who can demonstrate their ability to provide a modular wall system that can be used across various healthcare projects. Companies that will be included in the pre-qualification must be able to demonstrate:

- A robust modular wall system that meets the most current International healthcare requirements, including British and American standards.
- Demonstrate experience in the design, supply and installation of the modular wall system within the State of Qatar.
- Capacity and capability to deliver various projects at one time, this will include details of your production and / or manufacturing plants, delivery times and installation procedures.
- Understanding that the appointment, order and contract for the modular wall system will be done by a main contractor and not the PWA.
- An understanding of working in Qatar.
- A commitment to working with the PWA to achieve excellence for the State of Qatar.

#### **SCOPE OF SERVICES:**

The PWA wish to select a vendor list of suitable companies to provide modular wall systems for healthcare projects across the State of Qatar, which will provide standardisation, help improve construction quality and reduce lead in times.

The scope of work will include but is not limited to:

- The design, engineering, manufacture, supply and installation etc. of a modular wall system.
- Liaison with design teams to ensure the product is fit for purpose.
- Ensure the modular wall system meets the most current International healthcare standards.
- Ensure the modular wall system has flexibility to accommodate changes to the design, MEP services, healthcare medical equipment requirements and future modifications / refurbishment.
- Commitment to continually improve ways to improve lead in times.
- Commitment to continually improve ways to improve installation times.
