**ANTI-CORRUPTION AND CONFIDENTIALITY DECLARATION**

1. Anti-Corruption

The Bidder hereby represents and warrants that neither it nor any of its employees or representatives shall, receive nor offer, pay or promise to pay either directly or indirectly, bribes, gifts, commissions, considerations, inducements or rewards to a Public Official in connection with any business opportunities which, without limit, may arise in connection with the Services.

A Public Official is defined as:

- A. Any official or employee of any agency of Ashghal or a Government owned or controlled enterprise; and / or
- B. Any person performing a public function.

Furthermore, in the event that the Bidder receives a request from any Public Official requesting payments, bribes, gifts, commissions, considerations, inducements or rewards the Bidder shall disclose such to Ashghal immediately in writing with full particulars.

**2. Confidentiality**

The Bidder hereby represents and warrants that:

- A. All matters and details in connection with the Services shall be regarded as strictly private and confidential. Save as may be required by Law or by legal proceedings, government agency, or other consultants engaged by the Bidder for purposes in connection with the Services, no information contained within, or relating to, the Services shall be disclosed to any persons or other parties unless prior written authorisation of Ashghal is first obtained for any such disclosure;
- B. Where such information contained within, or relating to, the Services is to be disclosed the Bidder shall, prior to such disclosure, obtain Ashghal's non-objection;
- C. Conditional to the disclosure to a third party of any information contained within, or relating to, the Services the third party shall:
  - a. Commit to a like Anti-Corruption and Confidentiality Declaration; and
  - b. Commit that any copies or reproductions of the Expression of Interest Documents copied or conveyed are returned to the Bidder;
- D. Upon receipt of the Expression of Interest Documents the Bidder shall be bound unconditionally to comply in full with the confidentiality obligations specified within the Expression of Interest Documents.

**3. General**

The Bidder acknowledges that:

- A. Any breach of the declarations made herein may result in Ashghal suffering loss and / or damages and the Bidder hereby agrees to indemnify Ashghal against all expenses, losses and / or damages that may be sustained or incurred as a result either directly or indirectly of any such breach;
- B. In addition to any indemnities provided by the Bidder, Ashghal may, at its sole discretion, apply any of the following sanctions against the Bidder:
  - a. Warning; and / or
  - b. Lowering of the Bidder's category; and / or
  - c. Striking the Bidder's name from the register of approved Consultants for a certain period or permanently; and / or
